CHANGE OF COMPANY NAME

The Board is pleased to announce that the change of the English name of the Company from “Centenary United Holdings Limited” to “Zhong Ju Investment Group Limited” and the change of the dual foreign name in Chinese of the Company from “世紀聯合控股有限公司” to “中聚投資集團有限公司” have become effective on 23 January 2026.

CHANGE OF STOCK SHORT NAMES

The stock short name for trading in the Shares on the Stock Exchange will be changed from “CENT UNIT HLDG” to “ZHONG JU INVEST” in English and from “世紀聯合控股” to “中聚投資” in Chinese with effect from 9:00 a.m. on 4 March 2026. The stock code of the Company on the Stock Exchange will remain unchanged as “1959”.

The Company has adopted  as the new logo with effect from the date of this announcement.

References are made to the announcement of Zhong Ju Investment Group Limited (formerly known as “**Centenary United Holdings Limited**”) (the “**Company**”) dated 23 December 2025, the circular (the “**Circular**”) and the notice of the extraordinary general meeting (the “**EGM**”) of the Company both dated 2 January 2026 and the poll results announcement of the EGM dated 22 January 2026 in relation to, among others, the proposed Change of Company Name. Capitalised terms and expressions used in this announcement shall have the same meanings as those defined in the Circular unless otherwise stated.

CHANGE OF COMPANY NAME

The Board is pleased to announce that following the passing of the special resolution in relation to the Proposed Change of Company Name by the Shareholders at the EGM held on 22 January 2026, the certificate of incorporation on change of name was issued by the Registrar of Companies in the Cayman Islands certifying the English name of the Company has been changed from “Centenary United Holdings Limited” to “Zhong Ju Investment Group Limited” and the dual foreign name in Chinese of the Company has been changed from “世紀聯合控股有限公司” to “中聚投資集團有限公司”, both with effect from 23 January 2026.

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 13 February 2026 certifying that the English name of the Company registered in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the laws of Hong Kong) was changed from “Centenary United Holdings Limited” to “Zhong Ju Investment Group Limited” and the Chinese name was changed from “世紀聯合控股有限公司” to “中聚投資集團有限公司”.

CHANGE OF STOCK SHORT NAMES

The English stock short name for trading in the Shares on the Stock Exchange will be changed from “CENT UNIT HLDG” to “ZHONG JU INVEST” in English and from “世紀聯合控股” to “中聚投資” in Chinese with effect from 9:00 a.m. on 4 March 2026. The stock code of the Company on the Stock Exchange will remain unchanged as “1959”.

EFFECT OF THE CHANGE OF NAME

As mentioned in the Circular, the change of the Company’s name (the “**Change of Name**”) will not, itself, affect the rights of any Shareholders or the Company’s daily business operation and/or its financial position. All existing share certificates of the Company in issue bearing the former name of the Company, after the Change of Name having become effective, will continue to be valid evidence of legal title to the Shares and will continue to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of existing share certificates of the Company for

new share certificates bearing the Company's new name as a result of the Change of Name. After the Change of Name becomes effective, any issue of share certificates will be bearing the new English and dual foreign names of the Company.
